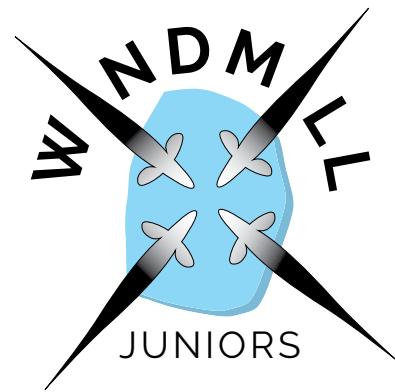

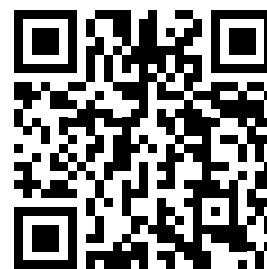

Windmill Angling Club are dedicated to creating a safe and secure environment for children and vulnerable individuals participating in our activities and under our care.

General Data Protection Regulation (GDPR) Policy

This policy sets out the obligations Windmill Angling Club (the Club) has in relation to data protection and the rights that members (data subjects) have in respect of their personal data. After the UK's exit from the EU, the General Data Protection Regulation (GDPR) has been retained in UK law and will continue to be read alongside the Data Protection Act 2018 regarding data protection and privacy in the United Kingdom.



All personal data will be processed in accordance with the following principles:

- Fairly, lawfully and transparently processed;
- Processed for limited purposes;
- Adequate and relevant and limited to what is necessary;
- Accurate and where possible up to date;
- Processed and kept in a way that ensures appropriate security.

Personal Data will not be processed unless:

- The member (data subject) has expressly consented to the process - please see below, or
- It is for the purpose of compliance with legal obligations, or
- It is necessary so as to pursue the club's interests, except where such interests are overridden by the fundamental rights and freedoms of the data subject (member) which require protection of personal data, in particular where the data subject is a child.

Data Breach Notification

Any and all personal data breaches must be reported immediately to the Committee.

Opt Out

It is impractical to offer any opt-out arrangements as it would result in multiple systems and alternative processes.

Implementation

This policy only applies to membership and matters occurring on or after this date.

*Photography and filming consent

We will not permit photographs, video or other images of young people to be taken without consent. If the child is under 18, consent must be obtained from a Parent/Guardian. All images will be stored on the Southern Advertising server and UK2 Web server only. Windmill Angling Club will take all steps to ensure these images are used solely for the purposes for which they are intended. If you become aware that these images are being used inappropriately, please inform us immediately.
